Regional Manager's Report



Findings of the recently published Study of the New Zealand Non-profit Sector Project*, suggest that the civil society sector of New Zealand is significant and growing, yet remains largely invisible and poorly resourced. This document is a real eye opener!

Not for Profit organisations represent a significant economic presence in New Zealand, in

addition to their social and political importance. The NFP Sector of New Zealand currently contributes more than \$10 billion to the economy in operation expenditure, employing approx 201,000 full time equivalent jobs, which is 9.6% of the economically active population of New Zealand, and 4.9% of the GDP. The sector engages a workforce that is larger than the Construction and Transport industries combined, and is a similar size to the Manufacturing sector of New Zealand. What is especially important to note, is the huge number of volunteers working within and alongside these widespread organisations, involving cultural, sports and recreation, health education and social services, welfare and community support services, environmental protection, civic activism, unions and professional associations, and religious worship activities.

This is however a fragile sector. NFP organisations in New Zealand rely greatly on goodwill and a high level of volunteer engagement as well as philanthropic contributions in order to survive. They receive 75% of their income from fees and philanthropy and only 25% from government support, comparatively low compared with other countries. Few if any would survive without volunteers. Increased regulation plus increased social pressures towards 'professionalisation', and major demographic and workforce changes such as our aging population and the increasing number of paid working parents all impact on the ability of NFP organisations to engage and retain volunteer staff.

The time for the Not for Profit Sector of New Zealand to be recognised widely as an important contributor to the economy as a whole is long overdue, especially by the commercial sector groups of this country, as well as the government.

Finally I would like to thank the staff and volunteers who have dedicated their time, energy and passion to make Volunteering Auckland the success that it is. Without you all we would not be where we are today. May we continue to walk together to promote and support volunteering in the greater Auckland region.



Overview of the Year

The 2007-2008 year has been an extremely busy and exciting year for Volunteering Auckland. Our aim to run an effective and efficient volunteer centre has resulted in expansion into additional office space, already fully utilised for research and ongoing project and services purposes, and allowing better space for reception, our volunteer referral service, and also administration. Our outdated telephone system has been replaced, and we have a new computer system and 4 new computers and workstations installed, allowing the development of better servicing systems. Special thanks to Microsoft for the donation of our updated software and operating systems.



Volunteering Auckland has made an increased number of submissions to both local and central government in the past year regarding issues affecting volunteering, both for volunteers, and for organisations that rely on volunteer support. Submissions were made to the Immigration Review Bill, Auckland Regional Services Amenities Bill and the Tax Reimbursements of Honoraria and Volunteer Expenses discussion document.

The Chairperson and Regional Manager attended the Volunteering New Zealand conference held at Te Papa in Wellington "Optimising the Energy of Volunteering" in November 2007, which was hugely beneficial, and Volunteering Auckland hosted the New Zealand Volunteer Centre Forum held in May 2008, a very useful forum attended by 36 participants from most if not all the 15 Volunteer Centres in New Zealand, allowing issues to be aired, networks to be strengthened, as well as support and ideas to be shared.

Volunteering Auckland has also been involved in other successful projects included the launch of The NZ Fire Service Ambassadors project on the 23rd of October 2007 to raise awareness among international students on the NZ Fire Service, the Sylvia Park Christmas wrapping project from December 8th to the 24th 2007, and 15 names being put forward for a TV programme about people with a disability volunteering in their communities, one of whom appeared on the programme!



Recruitment & Referral Service

As shown in Graph "Year End Volunteer Figures 2000 – 2008" the total number of people contacting us for voluntary roles has changed little from last year, however, there has been a dip in numbers coming through our Recruitment and Referral programme [R&R] for ongoing voluntary roles. On the other hand there has been tremendous growth with the Group Team Volunteering programme which brings us to a total similar to last year.

It has been in particular the first months of 2008 that have shown a real drop in both numbers of



potential volunteers who have come to our centre through the R&R programme and in the referrals and successful placements made to our member organisations.

We are not sure why this came about, though we know that figures do go up and down throughout any year in relation to what is happening with the economy and education sector etc; e.g. at exam time our student numbers drop way down, when there are plenty of paid work options the number of enquiries also drop. If the weather is fabulous numbers are down and the same for poor weather, this tends to affect the numbers of 'no-shows' to the appointments made by individuals. Prospective volunteers can be a fickle and transient bunch... but, when you capture their hearts it's a different story!!

Usually we have a steady flow during the year even without advertising as volunteering is generally very popular with all age-groups and backgrounds, but when it became apparent in May 2008 that the figures for the R&R programme were down we decided it was time to review our internal processes and put the recently created recruitment plan for both our members' volunteer needs and our own staffing needs into action.

Aside from outside influences, over which we have little control, we have gone through identifying barriers we may have had in place, our staffing levels and training, the interview and referral process, our contacts with member organisations and reviewing the volunteering opportunities that are listed with us.

At the time of writing we have nearly completed this review and have started implementing the changes needed that we have identified so far and feel quietly optimistic about the coming year.

Group/Team Volunteering

Volunteering Auckland activities in the past year have been many and varied with our newly named Group/Team Volunteering Programme. We have co-ordinated a number of major projects this year, including 42 one-day Group/Team projects involving 967 volunteers, with the biggest being 3 projects in one day, with approx 650 volunteers from the Church of Latter Day Saints in "Helping Hands 08". Planning is already underway for "Helping Hands" 2009.

We have also employed Myra Spence as our Services Coordinator who will further develop and implement the next phase of the Group/Team Volunteering Programme to meet the rapidly increasing demand coming in from Corporate Teams.

Outreach

Outreach beyond the Auckland region continues to make progress. In June 2008, a presentation was made at a community meeting in Kaikohe to assist the development of the Volunteering Mid-North Centre. This Volunteer Centre is due to be officially opened in September/October 2008.

Outreach within greater Auckland is still being discussed as to ways to move this forward. Whether it will be a physical presence and/or a web presence is still being determined based on the resources required and support from local government and organisations involving volunteers.

Training, Information and Consultation Services

There has been increasing participation in training workshops by NFP organisations, particularly in conjunction with local government funders. Volunteering Auckland recognises the high value in partnering with local councils to facilitate these workshops. Working in partnership with Manukau City and the combined partnership of Waitakere City, UNITEC, Community Waitakere and Sport Waitakere on training provision has proven to be very successful. In addition, continuing partnerships with UNITEC and AUT are developing well, and progress is underway to establish a similar partnership with the North Shore City Council.

12 training workshops were conducted during the year with 261 participants from across the greater Auckland NFP sector including sporting groups, conservation groups, health and social services. Topics covered included the motivation and recognition of volunteers for retention, recruitment, screening and selection of volunteers, policy development for involving volunteers, dealing with HR difficulties and managing change for volunteers, health and safety issues relating to volunteers, and OSH and risk management processes. An increasing number of NFP organisations are recognising the need for training in volunteer management, and utilising the resources that Volunteering Auckland has to offer.

Media and Promotions

A partnership between Volunteering Auckland and AUT's School of Journalism was established this year with the third year students given the opportunity to write and have published in local media stories about greater Auckland's volunteers. This opportunity gave the students "real-time" experience to assist them towards their degrees.


Two DVDs were developed to promote both volunteering and the opportunities for corporate teams to engage with volunteering projects and programmes. The DVD "A Break from the Fast Lane" was launched in July 2007 at the ANZ National Bank. Both are available to view on Youtube, with "A Break from the Fast Lane" being part of a promotion to raise funds for Volunteering Auckland.



Volunteering Auckland received exposure to the Asian community when the Regional Manager was interviewed on 'Asia Down Under' television in July 2007, highlighting volunteering opportunities for Asian community members. She was also interviewed on Planet FM regarding migrants and volunteering opportunities in greater Auckland.

The Sylvia Park Christmas wrapping project was an opportune event to promote Volunteering Auckland and volunteering generally to thousands of people. In addition to raising more than \$18,000 towards replacing our outdated IT system, a minimum of 2,000 people were spoken with during the two week promotion, and 1500 Volunteering Auckland flyers were distributed.

During the 2007-2008 year Volunteering Auckland has been mentioned on Planet FM and the Breeze, in the NZ Herald and several regional newspapers, on the internet through Youtube and the website, and to various community groups when the Regional Manager has been an invited speaker. Getting our stories into local media continues to be a priority for Volunteering Auckland as we know that the more people hear about volunteering and the many and varied opportunities that are available the more likely they will be inspired to contribute as a volunteer themselves!



Research

The research project "Asian People and their Choice in Volunteering" was completed during this period. This research was undertaken by Volunteering Auckland in order to understand the opinions and characteristics of current volunteering by the Chinese community in the greater Auckland region and to use the analysis of the research to support Volunteering Auckland's future marketing promotion of volunteering to the Chinese community. A descriptive and exploratory survey questionnaire was the primary research tool. This research

obtained a total of 30 completed questionnaires via email from a total of 118 emails sent (27% response rate). 367 people were chosen from Volunteering Auckland's database, which had more than 2000 volunteer registrations, from August 2004 to July 2007. These registrations were narrowed down to 220, due to not all of them having started their voluntary activity since they registered with Volunteering Auckland. This research is being duplicated with the Indian community which is about 80% completed at the time of writing.

We were greeted by Scott Thiemann, the CCS Disability Action Community Gardens Supervisor. Scott showed the team around the gardens and provided us with a good insight as to what the Horizon Gardens are looking to achieve.

Off to work we go, getting on with a number of different gardening related tasks. These included weeding, potting, planting, digging & plenty of moving soil in wheelbarrows.

During the course of the day each of we had a chance to have a go at each of the tasks at hand. The team were of varying backgrounds (and gardening experience), and as such Scott was able to provide us with an education in gardening along the way.

After an honest day's work, I have to say that it was most satisfying that we were able to see the difference that we had made to the gardens. It's fair to say that there is more work needing to be done, however we all look forward to the "finished product" and wish CCS Disability Action all the very best for the remainder of the project.

Audit Report

TO READERS OF THE FINANCIAL STATEMENTS OF THE VOLUNTEERING AUCKLAND TRUST

I have audited the attached financial report of the Volunteering Auckland Trust The report provides information about the past financial performance of the Trust and its financial position as at 30 June 2008.

Trust's Responsibilities

The Trust and its officers are responsible for the preparation of the financial statements and for ensuring that they fairly reflect the financial position of the Volunteering Auckland Trust as at 30 June 2008 and the results of its operations and cash flows for the year ended on that date.

Auditor's Responsibilities

Basis of Opinion.

- whether the accounting policies of the Volunteering Auckland Trust are appropriate to the circumstances, consistently applied and adequately disclosed.

I conducted my audit in accordance with generally accepted auditing standards in New Zealand. I planned and performed my audit so as to obtain all the information and explanations which I considered necessary to provide me with sufficient evidence to give reasonable assurance that the financial statements are free from misstatements, whether caused by error or fraud. In forming my opinion I also evaluated the overall adequacy of the presentation of information in the financial statements.

Other than in my capacity as auditor I have no relationship with or interests in the Volunteering Auckland Trust

Uncertainty

In common with other organisations of a similar nature, control over Income prior to its being recorded is limited and there are no practical audit procedures to determine the effect of the limited control.

Unqualified Opinion

I have obtained all the information that I have required.

Proper accounting records have been kept as far as appears from my examination of those records; and the Financial Statements on pages 3 to 8 fairly reflect the transactions of the Volunteering Auckland Trust for the year ended 30 June 2008 and its operations for the year ended on that date.

Notes to Financial Statements

Volunteering Auckland Trust

1) STATEMENT OF ACCOUNTING POLICIES

These are the financial statements of the Volunteering Auckland Trust incorporated on the 24th August 1992.

The financial statements have been prepared in accordance with generally accepted accounting principles.

1.1 Measurement System

The measurement system adopted is that of historical cost.

1.2 Particular Accounting Policies

The following is a summary of the significant accounting policies adopted by the trust in the preparation of these financial statements.

Accounts Receivable

Accounts receivable are stated at their estimated net realisable value.

Fixed Assets & Depreciation

Fixed Assets are included at cost less aggregate depreciation. Depreciation of fixed assets, other than Freehold Land, is calculated on a diminishing value basis so as to allocate the cost of the assets over their useful lives. The rates of depreciation are shown in the Fixed Asset Schedule forming part of these financial statements.

Goods and Service Tax

Financial information in these accounts is recorded exclusive of G.S.T. costs. G.S.T. payable or receivable at balance date is included in the appropriate category in the Statement of Financial Position.

Differential Reporting

The trust qualifies for differential reporting as it is not publicly accountable and it meets the size criteria. The trust has taken advantage of all available differential reporting exemptions.

1.3 Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years except for Income in Advance which has previously not been recognised.

1.4 Grants and Donations - details
